Although Haiti is the 2nd poorest country in the world there are many other orphans in need and ACHF has assisted children in China Bulgaria Peru South Korea Mexico Angola and the Ukraine By assisting existing orphanages in these countries we have blessed the lives of hundreds of children Due to recent economic challenges and political instability around the world ACHF focused its 2011 volunteer efforts in Mexico In addition to the food clothing hygiene kits educational and medical supplies we provided in Mexico ACHF has completed construction projects at four different orphanages and a care providers home These projects included cement pads retaining walls sidewalks landscaping painting plastering plumbing and electrical work We have also expanded kitchens tiled bathrooms and placed a roof on a girls dorm In addition our volunteers help in a food kitchen and spend individual time each day playing with the orphans
