**Service Trips - In 2018, ACHF continued its volunteer efforts exclusively in Mexico. We ran 24 Mexico service trips, taking 1,014 volunteers to three orphanages in Baja California, Mexico: Casa Hogar Buena Vida, Rancho de los Ninos, and Casa Hogar de Maria Inmaculada A.C (Hacienda). We also took volunteers to Rancho Del Nino orphanage in Guaymas, Sonora, Mexico. On these trips, we delivered groceries, toys, clothing, educational and medical supplies. We purchased building materials for our volunteers to repair and remodel these orphanages, as well as to complete the new campus and additional volunteer lodging for Casa Hogar Buena Vida. Additionally, we focused on building relationships with the children by playing with them and taking them on outings to the zoo, beach, and soccer fields.**

**Program Grants - Outside of monetary and supply donations given to orphanages as part of our volunteer service trips, ACHF gave monetary donations and grants to five orphanages and one domestic organization in 2018. Four of the orphanages are Mexican orphanages and one is the CSEDI orphanage in Haiti. The domestic organization is We Are Church (formerly known as Baja Family Outreach), a group that assists impoverished children in Tijuana. We granted \$143,250 to the orphanage in Haiti to purchase the land the orphanage is located on. Purchasing the land allowed the orphanage to begin expanding and making permanent improvements to their structures. Of the remaining amount, 65% was used by the orphanages for their day-to-day operations, such as buying groceries and paying their bills; 19% was used specifically for supplies for nursery-aged children (newborn to five years of age); 9% was used for the children's education, including \$1,900 given to We Are Church to purchase uniforms for the children they assist; 5% was used for Christmas gifts for the children at the orphanages; and the remaining 2% was used for construction projects at the orphanages. In addition to these grants, ACHF also granted \$690 in scholarships to a volunteer family to enable them to attend one of our service trips.**
